



FGCU Early Admission Information for Students



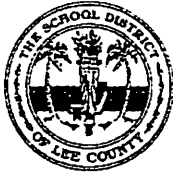
Students interested in early admission opportunities at Florida Gulf Coast University are required to schedule an appointment with their school counselor to determine whether initial eligibility criteria has been met. Once that determination has been made, students will be provided information regarding the necessary application, testing, and registration processes to follow.

Criteria for FGCU's Accelerated Collegiate Experience (ACE) Program:

- ✓ At time of application, be a rising junior or senior in high school.
 - Completion of a minimum of 4 semesters of high school (student should not have completed sufficient units to qualify for high school graduation, and must apply all credits earned to meeting high school graduation requirements and University criteria for degree completion).
 - ✓ Demonstrated exceptional ability as substantiated by a recommendation from the high school.
 - ✓ Completed ACE online application and associated forms.
 - ✓ Approval of parent or guardian.
 - ✓ A minimum 3.7 weighted high school grade point average **AND** a minimum 3.0 unweighted high school grade point average.
 - ✓ Composite test scores on the ACT of 23 or higher (including combined English/writing subtest with score of 20 or higher), **AND** minimum score of 20 for English, math, and reading subtests.
- OR
- ✓ Composite test scores on the SAT of 1600 or higher (total of critical reading, math, and writing) **AND** minimum score of 500 for critical reading, writing and math subtests.
 - ✓ Approval of the Director of the Accelerated Collegiate Experience.

Students must be eligible under an Accelerated Credit Contractual Agreement between FGCU and the student's current institution.

FLORIDA SOUTHWESTERN STATE COLLEGIATE INSTITUTE REQUIREMENTS

Florida SouthWestern Collegiate Institute (CI) is an accelerated articulation program in partnership between Florida SouthWestern State College and the School District of Lee County. It is designed to provide high achieving students with a more rigorous and academically challenging curriculum. CI is a status assigned to a high school student who is enrolled full-time at Florida SouthWestern State College in college-level courses during both the junior and senior years of high school. To be eligible, students must possess excellent test scores and demonstrate exemplary academic achievement prior to the end of the sophomore year of high school.

COLLEGIATE INSTITUTE REQUIREMENTS FOR A RISING JUNIOR

1. Have earned at least 14 credits by the end of the sophomore year
2. Received a passing score on Statewide Standardized Reading Assessment and Algebra I End of Course exam during the sophomore year
3. Have a 3.0 unweighted cumulative grade point average
4. Meet one of the test requirements
 114 Math, 106 Reading and 103 Writing on the PERT, or
 440 Math/440 Critical Reading on the SAT, or
 19 Reading, 17 English, 19 Math on the ACT
5. Provide one teacher and one counselor recommendation
6. Submit a previously completed and graded writing assignment (i.e. high school research paper or essay)
7. Students with prior college credit from an institution or body other than Florida SouthWestern State College must submit official transcripts and/or score reports to the Office of the Registrar. This includes college credit earned at other colleges or through credit by examination (AP, IB, AICE, and/or CLEP).
